1:00 Break out session #1: Understanding managers' needs

Facilitators: Josie Quintrell and Whit Saumweber

This session will document the needs of managers for science information to address issues related to coastal inundation including coastal erosion, sea level rise, emergency response and flooding. The session will review the response from the pre-workshop survey to determine if the major issues are covered or if there are additional needs that should be identified. Example questions:

- 1) What kind of decisions do they make concerning inundation?
- 2) What data do they presently use?
- 3) What would they like to have?
- 4) Does the data need to in real time? Do they need trend data?
- 5) What kind of decision support tools (predictive models, etc)
- 6) What capacity do managers have for: accessing data and information (eg, should it be GIS compatible?), analysis of data, etc.
- 7) What are the managers top priorities for scientific information concerning inundation issues?
